### Name of the element:

1. What **category** does the element fall into? The same nine as in the Wiki-inventory.
2. **Location** Is the phenomenon attached to a certain area in Finland? Choose Finland, regions and/or municipalities
3. **Keywords** What else does the element involve? Separate keywords with a comma.
4. **Who practises the tradition or knows it well?** (500–4000 characters)
  - Consider who practices the tradition nowadays. Are the activities organised or is the tradition practiced in smaller, private communities?
  - What kind of communities practice activities related to the tradition nowadays? Are there NGO's or other organisations involved in the practice?
5. **How is the tradition practised today?** (500–5000 characters)
  - Describe here what the tradition is all about.
  - Are there different versions of the tradition?
6. **Describe the tradition's background and history** (500–5000 characters)
  - How has the tradition changed over time?
  - Please mention possible sources of information only in the section Bibliography and links (e.g. articles and histories, etc.)
7. **How does the transmission of the tradition take place?** (500–5000 characters)
  - How is the tradition passed on from generation to generation, community to community or from one community member to another?
  - What means of transmission are being used? (E.g. courses, training, events)
  - Is the tradition nowadays transmitted differently from the past? How has the transmission of the tradition changed over time?
8. **Safeguarding the tradition** (500-4000 characters) **NEW**
  - Are there any threats or risks to the vitality of the tradition?
  - What are the current measures taken and what more should be done?
9. **How is the tradition being documented?** (500–4000 characters) **NEW**
  - Are there records of the tradition in archives or collections?
  - Who is in charge of these collections?
10. **What does the future of the tradition look like?** (500–5000 characters)
  - In which direction is the tradition evolving?
  - How has the tradition affected the rest of society?
  - How do the diversity and the new forms of practises affect the future of the tradition?
